NOTICE OF PUBLIC MEETING

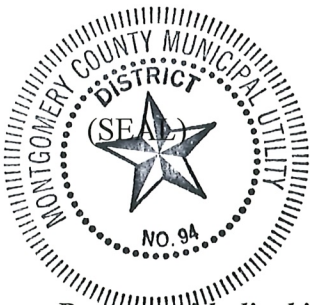
Notice is hereby given to all interested members of the public that the Board of Directors of the above captioned District will hold a regular public meeting at **1300 Post Oak Boulevard, Suite 2500, Houston, Harris County, Texas**, said address being a meeting place of the District. The meeting will be held on **Tuesday, September 1, 2026, at 12:00 Noon**. Said meeting may also be accessed by members of the public for observation purposes via telephone. To access the meeting for such purpose, the telephone number is 1-469-998-7488 and the access code is 39614476#. **Any members of the public doing so are requested to silence their phones in order to prevent excessive noise or interruption of the meeting.**

The Board shall consider and discuss the following matters and take any action appropriate with respect to such matters:

1. Public Comments;
2. Review and approve the minutes of the July 29, 2026 and August 4, 2026 Board of Directors meetings;
3. Report from Montgomery County Constable's Office regarding the provision of security services within the District;
4. Bookkeeper's Report, including financial and investment reports and authorizing the payment of invoices presented;
5. Report by Republic Services, Inc. concerning solid waste and recycling collection activities within the District;
6. Status of the District's Stormwater Management Program ("SWMP"), including any training necessary under the SWMP and comments from the public; Drainage Facilities Report and status of associated maintenance;
7. Tax Assessor/Collector's Report, including authorizing the payment of invoices presented and approve moving of accounts to uncollectible roll;
8. Report and legal action taken by the District's delinquent tax collection attorney, including authorizing foreclosure proceedings, installment agreements, and the filing of proofs of claim; authorize termination of water service as a means of collection of delinquent taxes and to prevent abuses;
9. Conduct a public hearing regarding the adoption of the District's 2026 tax rate;
10. Levy of the District's 2026 debt service and maintenance tax rates, and the adoption of an Order in connection therewith;
11. Approval and execution of an Amended District Information Form;

12. Operations Report, including:
 - (a) Authorizing the repair and maintenance of, or measures to protect, District facilities, including:
 - (i) Status of replacement of lift pumps located at Lift Station No. 2;
 - (b) Appeals of District charges; and
 - (c) Referral of accounts for collection and approve write-off of uncollectible accounts;
13. Engineer's Report, including:
 - (a) Authorizing the design and/or advertisement for bids for construction and/or maintenance of facilities within the District, and acceptance of TEC Form 1295;
 - (b) Review and approval of any Storm Water Pollution Prevention Plans related to construction within or on behalf of the District;
 - (c) Authorizing the award of construction contracts or concurrence of award of contracts for the construction and/or repair of facilities within the District;
 - (d) Status of construction and/or repair of facilities to serve land within the District, including the approval of any pay estimates and/or change orders;
 - (i) Construction of new concrete Wastewater Treatment Plant by Reytec Construction Resources, Inc., on behalf of Montgomery County Municipal Utility District No. 119 ("No. 119") and District;
 - (ii) Rehabilitation of Lift Station No. 2 by CROM CFG Industries, LLC; and
 - (iii) Cleaning and televising of sanitary sewer collection system (Pro-Pipe Services, LLC);
 - (e) Acceptance of site and/or easement conveyances for facilities constructed or to be constructed for the District, and acceptance of facilities for operation and maintenance purposes; and
 - (f) Discussion regarding electrical evaluation and repair schedule for the Joint Wastewater Treatment Plant received from Harris County Water Control and Improvement District No. 92 ("No. 92"); evaluation of District's allocated capacity and participation in No. 92 plant;
 - (i) Status of No. 92's notice of violation from TCEQ;
 - (g) Status of route alignment study and modeling in connection with request for surface water from the SJRA; approval of revised letter agreement concerning sharing the costs for same with other district(s); Reimbursement Agreement between the District and SJRA concerning same; and
 - (h) Status of emergency generator at Water Plant; options for terminating existing Electricity Reliability Service Agreement and/or temporarily upsizing generator;
14. Discuss proposed November 2026 Bond Election, including status of contract with Touchstone District Services related to election communications program;
 - (a) Communications Committee report; and
 - (b) Election education meeting scheduled for October 13, 2026;

15. Discuss potential expansion of No. 119 Plant to serve District and amendment of Waste Disposal Agreement to address same; authorize any related action, including preparation of amendment to waste discharge permit;
16. Status of District's sale of capacity in No. 92 Plant to Spring Independent School District ("SISD") and SISD's approval of Purchase and Sale Agreement; status of Amended and Restated Wastewater Treatment Facilities Agreement among No. 92, District, and SISD to address same;
17. Discuss potential terms for District's terminating participation in No. 92 Plant; status of Memorandum of Understanding regarding same;
18. Discuss resident/Spring Trails Community Association, Inc. communications received and/or requested maintenance by District and related matters, including:
 - (a) Tree maintenance inquiries and/or work order forms;
19. District website report;
20. Discuss Professional Development Program workshops for Directors;
21. Attorney's Report;
 - (a) Status of SJRA Global GRP Contract Amendment; Notice of Vote on Final Global Amendment to Contracts for Groundwater Reduction Planning, Alternative Water Supply, and Related Goods and Services;
